ORDER

The appellant has preferred 1st appeal through online RTI portal vide No. PODEP/A/E/22/00108 dated 07.09.2022 against the disposal of her RTI application bearing No. PODEP/R/E/22/00620 dated 11.08.2022 by CPIO/East with the contentions that access to the information requested by her has been refused.

INFORMATION SOUGHT IN RTI APPLICATION :-

The appellant vide her RTI application dated 11.08.2022 had sought action taken reports, statements recorded, details of DDRs/FIRs if any, reasons for delay and action taken against police officials for non-registration of FIR etc pertaining to her complaints sent through email ID anugargchd@gmail.com to different authorities regarding cheating, forgery and outreach of modesty.

COMMENTS OF CPIO/East : -

Comments of CPIO/East have been obtained who submitted that RTI application of the appellant was received in his office through online RTI portal vide No. PODEP/R/E/22/00620 dated 11.08.2022. Accordingly, the report from SHO PS-26 was obtained and as per his report, all the complaints filed by the appellant were under enquiry, so the information sought by the appellant was denied as per provisions of section 8(1)(h) of RTI act through online RTI portal on dated 02.09.2022 vide letter No.232-RTI/CPIO/East, dated 27.08.2022.

DECISION :-


I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant vide her RTI application No. PODEP/R/E/22/00620 dated 11.08.2022 had sought action taken reports, statements recorded, details of DDRs/FIRs if any, reasons for delay and action taken against police officials for non-registration of FIR etc pertaining to her complaints sent through email ID anugargchd@gmail.com to different authorities regarding cheating, forgery and outreach of modesty. As at the time of disposing of RTI application of the appellant, all the complaints filed by her were under enquiry, so Information sought was rightly denied by CPIO/East u/s 8(1)(h) of RTI Act.

Moreover, office record in this regard also scrutinized and found that all the complaints filed by the appellant are still under enquiry, hence, CPIO/East is directed to supply the copy of her all complaints to the appellant. Furthermore, in the interest of justice as well as for the satisfaction of the appellant, CPIO/East is directed to verbally apprise the appellant about the current status/progress of the enquiry of her complaints.

So far as the other grievances of the appellant are concerned, appellant is hereby advised to approach the appropriate platform as this act provides a mechanism for supplying only available information to the appellant/applicant.

With these directions instant appeal stands disposed off.

In case, appellant is not satisfied with the disposal of her appeals, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
