ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/East in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was received from the office of FAA-cum-SSP/Sec. & Traffic vide letter no. D-1548/PA/SSP/Tr. & Sec. dated 17.12.2021 and the same was diarized vide No. 147/UT/RTI/FAA/SSP dated 23.12.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information on 04 points regarding case FIR No. 63/2021 lodged at PS- IT Park, Chandigarh i.e. Offending Vehicle No., Make of Vehicle, Insurer of Offending Vehicle and Certified copy of CCTV footage.

COMMENTS OF CPIO/East : -

Comments of CPIO/East submitted that report from SHO-IT Park has been obtained who submitted that FIR in question is still under investigation therefore sought information is denied u/s 8 (1) (h) of RTI Act. However, keeping in view of Appeal of the appellant, as confirmed by SHO/IT

Park, no accused has been arrested and no vehicle has been seized so far in the FIR.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant had sought information on 04 points regarding case FIR No. 63/2021 lodged at PS- IT Park, Chandigarh i.e. Offending Vehicle No., Make of Vehicle, Insurer of Offending Vehicle and Certified copy of CCTV footage.

It is clear from the comments of CPIO/East that part information was dealt by him i.e. first 03 points (Offending vehicle No., Make of Vehicle and Insurer of Offending Vehicle) and the same was denied u/s 8 (1) (h) of RTI Act, as the FIR was under investigation at that time. However, keeping in view of the fact that appellant is complainant in the said FIR and wants to invoke claim before the MACT, CPIO/East is hereby directed to provide the sought information to the appellant, if available as per RTI Act. With these observations, instant appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
