ORDER

The appellant has preferred her online 1st appeal bearing No. PODEP/A/E/23/00104 dated 10.09.2023 against the disposal of her RTI application bearing No. PODEP/R/E/23/00095 dated 05.02.2023 by CPIO/Hqrs with the contentions that requisite information was not supplied to her.

Information sought vide RTI application :

The appellant vide her RTI application dated 05.02.2023 had sought status of her complaint bearing No. ICMS/2023/000133 and all relevant documents.

Comments of CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office for supplying the requisite information. Accordingly, requisite information was obtained from I/C HAC who reported that complaint in question has been sent to the O/o Director General of Police, Punjab Police Headquarters, Sector 09, Chandigarh vide letter No. 585/UT/HAC dated 20.01.2023 for further taking necessary action at their own end. So, requisite information could not be supplied to the appellant and he was advised to approach the concerned SPIO of Punjab Police vide letter No. 33/CPIO/Hqrs/Online RTI-23, D-32 dated 24.02.2023.

Decision :-


I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that appellant had sought status of her complaint bearing No. ICMS/2023/000133 and all relevant documents.

In reply, CPIO/Hqrs has apprised the appellant that complaint bearing No. ICMS/2023/000133 alongwith all relevant documents, has already been sent to the O/o

Director General of Police, Punjab Police Headquarters, Sector 09, Chandigarh, hence, requisite information may be obtained from concerned SPIO of Punjab Police.

So far as the appeal of the appellant is concerned, the appellant has already been apprised by CPIO/Hqrs that her complaint alongwith all relevant documents, was transferred to Office of DGP, Punjab Police, so, she should approach the concerned SPIO of Punjab Police for requisite information as the requisite information is not under the custody of CPIO/Hqrs. Moreover, CPIO/Hqrs is hereby directed to supply the copy of transferring letter to the appellant in accordance with RTI act. With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
