## O R D E R

The appellant has preferred 1st appeal against the reply/order of CPIO/PHQ in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 91/UT/RTI/FAA/SSP dated 01.09.2021 for further proceeding under RTI Act.

As the RTI application is also marked to CPIO/Accounts, CPIO/PEB, CPIO/Establishment, CPIO/Lines and CPIO/Home Guards, therefore, instant appeal is transferred to concerned FAAs vide this office No. D-351-352/UT/RTI/FAA/SSP dated 22.09.2021 for dealing the same at their own end.

#### INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought the list of DSP's against whom Criminal/Civil complaints and its proceedings for last 10 years.

### COMMENTS OF CPIO/PHQ: -

CPIO/PHQ submitted that application of the appellant was received from the office of CPIO (Establishment) for supplying requisite information, only for point no. 1 which related with this office. The same was denied u/s 8(1)(j)of RTI Act as appellant is third party and he has no relevancy with the requisition information. Moreover, no larger public interest can be seen for disclosing the requisite information,

#### **DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/PHQ vis-à-vis material available on record which revealed that appellant had sought the list of DSP's against whom Criminal/Civil complaints and its proceedings for last 10 years.

Insofar as appeal is concerned, appellant has sought list of DSPs against whom Criminal/Civil complaints were filed in last 10 years in the department. CPIO/PHQ has aptly denied the partial information i.e. copy of complaint and its reports as the matter primarily related between employee and employer which attracts section 8(1)(j) of RTI Act being a personal information concerned DSPs and no larger public interest can be seen for furnishing the same. However, for achieving the objective of RTI Act, details of DSPs against whom Criminal/Civil complaints were filed in last 10 years can be provided without disclosing their personal information. Hence, instant appeal is hereby disposed of with the direction to CPIO/PHQ to supply the above mentioned information.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
