The appellant has preferred 1<sup>st</sup> appeal against the reply/order of CPIO/Central in connection with his RTI application with the contentions that requisite information was denied to him. The instant appeal was diarized vide No. 93/UT/RTI/FAA/SSP dated 07.09.2021 for further proceeding under RTI Act.

**INFORMATION SOUGHT IN RTI APPLICATION:-**

Appellant had sought information pertaining to complaint PW No. 202110269 i.e. copy and proceedings made in the complaint.

**COMMENTS OF CPIO/CENTRAL: -**

CPIO/Central submitted that application of the appellant was received for supplying requisite information and report from SHO/PS-17 was obtained, thereafter, requisite information was denied


u/s 8(1)(j) of RTI Act as neither the appellant is complainant nor alleged in the above mentioned complaint.

**DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought information pertaining to complaint PW No. 202110269 i.e. Copy and proceedings made in the complaint.

Insofar appeal is concerned; it is clear from the reply of CPIO/Central that appellant is not directly related with the matter i.e. neither complainant nor alleged in the complaint in question i.e. PW No. 202110269, moreover, no larger public interest can be seen for disclosing the same, thus, CPIO/Central had appropriately applied section 8(1)(j) of RTI Act. Hence, no intervention is warranted in appeal, accordingly the same is hereby disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
