ORDER

The appellant has preferred his online 1st appeal bearing No. PODEP/A/E/23/00105 dated 11.09.2023 against the disposal of his RTI application bearing No. PODEP/R/E/23/00650 dated 31.07.2023 by CPIO/South-West with the contentions that requisite information was not supplied to him.

Information sought vide RTI application :

The appellant vide her RTI application dated 31.07.2023 had sought information regarding cases pending with CFSL, dates of cases referred to CFSL, Place of occurrence & concerned Police Station, type of cases (POCSO, murder, Sexual Assault etc.), reasons for delay, average cases received per month, posted strength and budget etc.

Comments of CPIO/South-West :-

CPIO/South-West vide his comments submitted that RTI application of the appellant was received in his office for supplying the requisite information. Thereafter, appellant (Navdeep Mishra) sent an e-mail from his mail id. (deepnav.mishra@gmail.com) to the undersigned stating therein that he has filed the RTI application to obtain the information from CFSL but the same was mis-sent to Police Department and he does not want any reply from Chandigarh Police. Reply of the same was sent to the appellant within time vide No. 180-RTI/CPIO/South West dated, Chandigarh 24.08.2023. Further, he was telephonically contacted regarding his first appeal where he disclosed that he filed the first appeal against the reply of CFSL and he also sent an e-mail from his mail id. (deepnav.mishra@gmail.com) to the undersigned stating that no action is needed on the part of Chandigarh Police.


Decision :-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South-West vis-à-vis material available on record which revealed that appellant had sought misc. information regarding cases pending with CFSL, dates of cases referred to CFSL, Place of occurrence & concerned Police Station, type of cases (POCSO, murder, Sexual Assault etc.), reasons for delay, average cases received per month, posted strength and budget etc.

In reply, CPIO/South-West when contacted the appellant for requisite information, he sent an e-mail from his mail id. (deepnav.mishra@gmail.com) to the undersigned stating therein that he has filed the RTI application to obtain the information from CFSL but the same was mis-sent to Police Department and he does not want any reply from Chandigarh Police.

So far as the appeal is concerned, the appellant agains contacted, in turn, he disclosed that he filed his first appeal against the reply of CFSL and also sent an e-mail from his mail id. (deepnav.mishra@gmail.com) to the undersigned stating that no action is needed on the part of Chandigarh Police. So, there is niether any delay nor any denial on the part of CPIO. Hence, no more action is required to be taken on the instant appeal and the same is hereby disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
