

**THE SENIOR SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE  
AUTHORITY-ACCOUNTS, UNDER RIGHT TO INFORMATION ACT, 2005.**

**Order on First Appeal u/s 19 RTI Act.**

This is an order on an online appeal preferred by Sh. Jagjeet Singh R/o # 5080/2, Modern Housing Complex, Mani Majra, Chandigarh under RTI Act 2005, received in this office through the RTI Request & Appeal Management Information System(RTI-MIS) bearing No. PODEP/A/E/23/00028 dated 27/03/2023, against the disposal of his online RTI Application bearing No. PODEP/R/T/23/00007 dated 15/02/2023 by DSP-cum-CPIO/Accounts.

(2) The appellant, vide his application dated 15/02/2023 under RTI Act 2005, had requested CPIO/Chandigarh Administration to provide Certified copy of an internal inquiry report along with all annexure. CPIO/Chandigarh Administration further transferred the RTI application on 17/03/2023 to Nodal Officer PHQ for its disposal. Nodal Officer/PHQ further transferred the online RTI application to DSP-cum-CPIO/Accounts for its proper disposal at his own level. CPIO/Accounts had disposed of the RTI application on 17/03/2023, vide No. 21/RTI/CPIO/Accounts/2023/ UT/10076.

(3) The appellant, being not satisfied with the manner CPIO/Accounts has disposed his RTI application, has filed the instant online appeal to provide complete information.

(4) Comments of DSP-cum-CPIO/Accounts have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Accounts, the information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-

On 1.2.2023, in CRM-M No.30142 of 2020, Learned APP, UT, Chandigarh has filed an additional affidavit before the Honble High Court of Punjab and Haryana that an internal inquiry, which was pending before respondent No.8/Home Department, has been completed and approved on 14.11.2022. On 13.2.2023, the appellant was informed by the Superintendent Police, Chandigarh Administration that his RTI application has been sent to DSP-cum-CPIO/PHQ, Chandigarh. A copy of letter Endst No.43(RTI)-P-1/2023/2075 dated 13.2.2023 is attached herewith at A. <i>This RTI is related to contain corruption &amp; preservation of evidences. But, delayed is being made deliberately and malafide intentions prove from the fact that concerned CPIO has made false claim that reply of the RTI application has been sent to the appellant vide No.21/RTI/CPIO/ Accts/2023/UT/10076 dated 17.3.2023.</i> A copy of same is also attached at B. Whereas, ten days have passed but no copy of reply has been delivered to the appellant from any type of communication. It is, therefore, again requested that the concerned CPIO may be directed to provide point-wise	CPIO/Accounts vide his comments has submitted that the online RTI application in question was received in his office on 15.02.2023, bearing No. PODEP/R/T/23/00007 through online RTI Portal and the same was disposed of vide No. 21/RTI/CPIO/Accounts/2023/ UT/10076 dated 17.03.2023 within stipulated time period. However, in the instant appeal the appellant has mentioned that <i>no copy of reply has been delivered to the appellant from any type of communication.</i> In the view of above, CPIO/Accounts is directed to contact appellant and provide him a copy of reply at the earliest. Further, certain allegations have been made against the CPIO by the applicant. Copy of allegations be supplied to the CPIO and he is directed to submit his reply with respect to the allegations.



		information within two days, if same is ready as claimed by him and impose penalties upon responsible CPIOs under the provisions of the RTI Act for such delay and strict action may also be taken for such misleading/false claim. Copy to the Home Secretary, Chandigarh for information w.r.t. his letter Endst No.43(RTI)-P-1/2023/2075 dated 13.2.2023 against RTI HOMED/R/E/23/00016 dated 5.2.2023. From 5.2.2023, total 57 days have passed.
