ORDER

The appellant has preferred his 1st appeal dated 21.12.2024 against the disposal of his RTI application dated 20.11.2024 by CPIO/Admn with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application had sought information regarding complaints bearing no. ICMS/2024/002128 and ICMS/2024/028579 i.e. copy of complaints, documents and final report.

COMMENTS OF CPIO/Admn.:-

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from concerned I/C HAC who reported that complaint in question i.e. ICMS/2024/002128 is filed in HAC Branch after the finalization of the enquiry. Hence, sought information was supplied to the applicant in the shape of 14 pages vide letter no. 466/RTI-24/DSP/Admn dated 09.12.2024.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information regarding complaints bearing no. ICMS/2024/002128 and ICMS/2024/028579 i.e. copy of complaints, documents and final report.

In reply, CPIO/Admn has provided the sought information to the applicant in the shape of 14 pages.

Now as far as appeal is concerned, CPIO has already provided the requisite information regarding complaint bearing no. ICMS/2024/002128 in the shape of 14 pages to the applicant. Hence, no more action is required to be taken on this instant first appeal.

However, applicant has preferred his 1st appeal with the contentions that he has received information regarding complaint bearing no. ICMS/2024/002128, but has not received information regarding complaint bearing no. ICMS/2024/028579.

In this regard, CPIO/Admn has already transferred the part RTI application to CPIO/W&CSU manually and through online portal. Therefore, applicant is hereby advised to apply a fresh appeal to the concerned appellant authority, as necessary action has already been taken on the RTI application by CPIO/Admn.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
