ORDER

The appellant has preferred his 1st appeal dated 25.09.2022 (received in this office on 06.10.2022) in connection with his RTI application dated 03.08.2022 with the contentions that he has not been supplied any information so far.

Information sought vide RTI application :

The appellant vide his RTI application 03.08.2022 had sought update, action taken report and all relevant documents related to a complaint which was sent by him to W/DGP through e- mail on dated 20.05.2022 at 08.52 am.

Comments of CPIOs :-

To proceed further in the matter, record of CAPIO/PHQ was scrutinized but no RTI application of the appellant found received there. So, comments of CPIO/PHQ, CPIO/Central, CPIO/East, CPIO/ North-East, CPIO/South and CPIO/South-West were also sought in this regard, but as per their reports, RTI application dated 03.08.2022 not found received to any of these CPIOs.

Decision :

I have gone through the contents of RTI application, appeal of the appellant, record of CAPIO/PHQ, comments of CPIO/PHQ, CPIO/Central, CPIO/East, CPIO/ North-East, CPIO/South and CPIO/South-West, vis-à-vis material available on record which revealed that the RTI application dated 03.08.2022 sent by the appellant

not found received by any of the CPIOs working under this authority. Hence, the instant appeal is not maintainable.

However, as per record of PWS/ICMS a complaint bearing No.ICMS/2022/005467 dated 08/06/2022 filed by the appellant against Jagdish Chand etc. is pending under enquiry with SHO PS-3. Therefore, to uphold the spirit of RTI Act as well as for the satisfaction of the appellant, CPIO/Central is hereby directed to apprise the appellant about the latest status of the complaint (ICMS/2022/005467) in accordance with RTI act.

With these directions, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
