THE SENIOR SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-ACCOUNTS, UNDER RIGHT TO INFORMATION ACT, 2005.

Order on First Appeal u/s 19 RTI Act.

This is an order on an online appeal preferred by Sh. Jasleen S Vohra r/o H.No 416/A, New Police Lines, Sector-26, Chandigarh under RTI Act 2005, received in this office through the RTI Request & Appeal Management Information System(RTI-MIS) bearing No. PODEP/A/E/23/00030 dated 01/04/2023, against the disposal of his online RTI Application bearing No. PODEP/R/E/23/00232 dated 29/03/2023 by DSP-cum-CPIO/Accounts.

- (2) The appellant, vide his application dated 29/03/2023 under RTI Act 2005, had requested Nodal Officer-PHQ to supply information in 03 points in connection to pension case of his father Lt SI Avtar Singh No. 828/CHG. Nodal Officer/PHQ further transferred the online RTI application to DSP-cum-CPIO/Accounts for its proper disposal at his own level. CPIO/Accounts had disposed of the RTI application on 31/03/2023, vide No. 41/RTI/CPIO/Accounts/2023/ UT/11952.
- (3) The appellant, being not satisfied with the manner CPIO/Accounts has disposed his RTI application, has filed the instant online appeal to provide complete information.
- (4) Comments of DSP-cum-CPIO/Accounts have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Accounts, the information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-
