## ORDER

The appellant has preferred online 1<sup>st</sup> appeal bearing No. PODEP/A/E/23/00076 dated 09.08.2023 against the disposal of his online RTI application bearing No. PODEP/R/E/23/00652/4 dated 31.07.2023 by CPIO/North-East with the contentions that incomplete, misleading and false information was provided to him.

## Information sought vide RTI application :-

The appellant vide his online RTI application had sought information on 03 points i.e. any police complaint/ police case filed against Arun Vohra, Ambika Vohra and Aarti Vohra R/o H. Nos. 5245 GF, Sector 38-West, Chandigarh, 532/1, Sector 38/A, Chandigarh, Flat No. 1230, Sector 52-D, Chandigarh and Flat No. 4837 Housing Board Society, Sector 38-West, Chandigarh in any Police Station of UT Chandigarh from January 2005 till 31 July 2023, How a family can take so many flats in UT Chandigarh and provide the phone number of flat allotment authority in UT Chandigarh and provide the emergency contact number of Life Safety Team of Chandigarh Police for saving life etc.

## COMMENTS OF CPIO/North-East :-

CPIO/North-East vide his comments submitted that RTI application of the appellant was received in this office to supply the requisite information. Accordingly, requisite information was obtained from all SHOs of North-East Sub Division and the same in point-wise form was provided to the appellant vide letter No. 127-RTI/CPIO/North-East dated 08.08.2023 with the comments that no case or complaint was found registered against the Arun Vohra, Ambika Vohra and Aarti Vohra and information pertaining to point no. 02 did not relate to their jurisdiction and with respect to point no. 03, emergency contact number i.e. 112 was provided to the appellant.

### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/North-East vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought information on 03 points i.e. any police complaint/ police case filed against Arun Vohra, Ambika Vohra and Aarti Vohra R/o H. Nos. 5245 GF, Sector 38-West, Chandigarh, 532/1, Sector 38/A, Chandigarh, Flat No. 1230, Sector 52-D, Chandigarh and Flat No. 4837 Housing Board Society, Sector 38-West, Chandigarh in any Police Station of UT Chandigarh from January 2005 till 31 July 2023, How a family can take so many flats in UT Chandigarh and provide the phone number of flat allotment authority in UT Chandigarh and provide the emergency contact number of Life Safety Team of Chandigarh Police for saving life etc.

In reply, CPIO/North-East supplied the point-wise information to the appellant.

So far as the appeal is concerned, appellant has already been informed that no case or complaint was found registered against the Arun Vohra, Ambika Vohra and Aarti Vohra R/o H. Nos. 5245 GF, Sector 38-West, Chandigarh, 532/1, Sector 38/A, Chandigarh, Flat No. 1230, Sector 52-D, Chandigarh and Flat No. 4837 Housing Board Society, Sector 38-West, Chandigarh. And with regard to information pertaining to point no. 02 is concerned, appellant was informed that it does not pertain to Chandigarh Police and any information regarding this can be obtained from Chandigarh Administration or Chandigarh Housing Board Authority. With respect to point no. 03, emergency contact number i.e. 112 was provided to the appellant.

Hence, available information was provided to the appellant so, no more action is warranted in the matter. With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
