### ORDER

The appellant has preferred online 1<sup>st</sup> appeal bearing No. PODEP/A/E/23/00077 dated 09.08.2023 against the disposal of his online RTI application bearing No. PODEP/R/E/23/00658/3 dated 03.08.2023 by CPIO/North-East with the contentions that incomplete, misleading or false information was provided to him.

## Information sought vide RTI application :-

The appellant vide his online RTI application had sought the certified copies of all criminal complaint/case/dispute filed against Janak Raj Vohra S/o Harnam Dass Vohra, Arun Vohra S/o Janak Raj Vohra, Ambika Vohra D/o Janak Raj Vohra and Aarti Vohra D/o Janak Raj Vohra R/o H. Nos. 41, Sector 16A, Chandigarh, 5245 GF, Sector 38-West, Chandigarh, 532/1, Sector 38/A, Chandigarh, Flat No. 1230, Sector 52-D, Chandigarh and Flat No. 4837 Housing Board Society, Sector 38-West, Chandigarh in any Police Station of UT Chandigarh/Govt. of India from January 2000 till 03 August 2023 alongwith their status reports etc.

## COMMENTS OF CPIO/North-East :-

CPIO/North-East vide his comments submitted that RTI application of the appellant was received in his office to supply the requisite information. Accordingly, requisite information was obtained from all SHOs of North-East Sub Division and the appellant was informed vide letter No. 127-RTI/CPIO/North-East dated 08.08.2023 that no case or complaint was found registered against Janak Raj Vohra S/o Harnam Dass Vohra, Arun Vohra S/o Janak Raj Vohra, Ambika Vohra D/o Janak Raj Vohra and Aarti Vohra D/o Janak Raj Vohra R/o H. Nos. 41, Sector 16A, Chandigarh, 5245 GF, Sector 38-West, Chandigarh, 532/1, Sector 38/A, Chandigarh, Flat No. 1230, Sector 52-D, Chandigarh and Flat No. 4837 Housing Board Society, Sector 38-West, Chandigarh.

#### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/North-East vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought the certified copies of all criminal complaints/cases/disputes filed against Janak Raj Vohra S/o Harnam Dass Vohra, Arun Vohra S/o Janak Raj Vohra, Ambika Vohra D/o Janak Raj Vohra and Aarti Vohra D/o Janak Raj Vohra R/o H. Nos. 41, Sector 16A, Chandigarh, 5245 GF, Sector 38-West, Chandigarh, 532/1, Sector 38/A, Chandigarh, Flat No. 1230, Sector 52-D, Chandigarh and Flat No. 4837 Housing Board Society, Sector 38-West, Chandigarh in any Police Station of UT Chandigarh or India from January 2000 till 03 August 2023 alongwith their status reports etc.

So far as the appeal is concerned, appellant has already been apprised by the CPIO that no criminal complaints/cases/disputes filed against Janak Raj Vohra S/o Harnam Dass Vohra, Arun Vohra S/o Janak Raj Vohra, Ambika Vohra D/o Janak Raj Vohra and Aarti Vohra D/o Janak Raj Vohra from January 2000 till 03 August 2023.

Hence, available information was supplied to the appellant by CPIO/North-East so, no more action is warranted in the matter. With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
