# ORDER

The appellant has preferred 1st appeal (bearing No. PODEP/A/E/21/00075 dated 22.09.2021) against the reply of CPIO/South in connection with RTI application (bearing No. PODEP/R/E/21/00495 dated 30.08.2021) with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide No. 100/UT/RTI/FAA/SSP dated 22.09.2021 for further proceeding under RTI Act.

# INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information on 04 points regarding his all pending complaints and another 05 points information pertaining to complaint No. PW202109796.

## COMMENTS OF CPIO/SOUTH: -

CPIO/South submitted that appellant has sought information vide his online RTI application. Thereafter, requisite information was obtained from SHO/PS-34 and point wise reply was

supplied to the appellant, hence no information is left for supplying on their part.

### **DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Swith vis-à-vis material available on record which revealed that appellant had sought information on 04 points regarding his all pending complaints and another 05 points information pertaining to complaint No. PW202109796.

Insofar as appeal is concerned, it is clear that CPIO/South has already provided information on 05 points pertaining to complaint bearing No. PW202109796 to the appellant. Hence, no more action is required on these points. In addition to these 5 points, appellant has sought information on 04 points regarding all his complaints which has not been provided to him. Hence, CPIO/South is hereby directed to furnish the requisite information/data on these 04 points to the appellant as per RTI Act. With these directions, appeal is hereby disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
