**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal against the reply of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 148/UT/RTI/FAA/SSP dated 27.12.2021.

**INFORMATION SOUGHT VIDE RTI APPLICATION:**

The appellant had sought information regarding letter of SDM(S) bearing no. SDA/2021/2450 & SDA/2021/4268 dated 11.12.2020 & 26.06.2021, marked to SHO-34.

**COMMENTS OF CPIO/South: -**

CPIO CPIO/South submitted that appellant has sought information through RTI application. Thereafter, report from SHO/34 was obtained, who submitted that the said reference has been sent to SDM South through proper channel. Appellant has been apprised about the same vide No. 578/CPIO/South/Dated 17.12.2021.

**DECISION:**

I have gone through the contents of RTI application, appeal of the appellant, vis-à-vis material available on record which revealed that appellant had sought information regarding letter of SDM(S) bearing no. SDA/2021/2450 & SDA/2021/4268 dated 11.12.2020 & 26.06.2021, marked to SHO-34.

Whereas, CPIO has already apprised about the status of reference letter no. SDM(S)/SDA/2021/4268 to the appellant. Now in appeal, appellant has raised grievances which is not covered under the definition of Information' and 'Right to information' delineated u/s 2 (f) of RTI Act. However, CPIO/South is

hereby directed to apprise about the current status of the reference in question.  
Appeal stands disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
