ORDER

The appellant has preferred 1st appeal dated 25.09.2024 against the disposal of his RTI application dated 27.08.2024 by CPIO/South-West with the contentions that requisite information was not provided to him.

Information sought vide RTI application:-

The appellant vide his RTI application has sought information CCTV footage dated 30.04.2023 of Police Station 39, Chandigarh regarding his attendance.

COMMENTS OF CPIO/South-West :-

CPIO/South-West vide his comments submitted that RTI application was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from DSP-cum-CPIO/Traffic being custodian of record and the same was denied to the applicant as the requisite CCTV footage is not available in the record. Applicant was apprised about the same vide no. 195-RTI/CPIO/South West dated 13.09.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/S-West vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought information CCTV footage dated 30.04.2023 of Police Station 39, Chandigarh regarding his attendance.

In reply, CPIO/South-West has already apprised the appellant about the CCTV footage.

Now as far as the appear is appropriately disposed of the RTI application, as no CCTV footage is available information can be provided by the CDIA Now as far as the appeal is concerned, CPIO/South-West has appropriately disposed or une , ...
record, as only available information can be provided by the CPIO III. Hence, no more action is required to be taken on this annual



With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Ma Munirka, New Delhi-110067 under the RTI Act within 90 days.
