ORDER

The appellant has preferred online 1st appeal bearing No. PODEP/A/E/23/00078 dated 10.08.2023 against the disposal of his online RTI application bearing No. PODEP/R/E/23/00604/1 dated 18.07.2023 by CPIO/Hqrs. with the contentions that complete information be provided to him.

Information sought vide RTI application :-

The appellant vide his online RTI application had sought information on 03 points regarding complaint bearing No. PW2022-10279 dated 13.05.2022 i.e. action taken upon complaint, copy of statements taken and copy of rules for disposal of complaints by Chandigarh Police etc.

COMMENTS OF CPIO/South-West :-

CPIO/South-West vide his comments submitted that RTI application of the appellant was received in his office to supply the information regarding complaint bearing No. PW202210279 dated 13.05.2022. Thereafter, requisite information was obtained from SHO Police Station Maloya who reported that the said complaint has already been send to senior officer after enquiry for finalization. Accordingly, RTI application was also transferred to CPIO/Hqrs accordingly vide letter No. 161-RTI/CPIO/South-West/Dated 31.07.2023. However, RTI application was again transferred back from CPIO/Hqrs to CPIO/South-West vide No. 241/CPIO/Hqrs/Online RTI-23 D-171 Dated, Chandigarh the: 08.08.2023 as compliant in question was sent to Police Station- Maloya for further enquiry. Accordingly, sought information was denied to the applicant as per provisions of section 8(1)(h) of RTI Act, 2005 vide letter No. 161-A-RTI/CPIO/South-West/Dated, Chandigarh, the: 17.08.2023.

COMMENTS OF CPIO/HQ :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office from CPIO/South-West to supply the information regarding complaint bearing No. PW202210279 dated 13.05.2022. Thereafter, requisite information was obtained from I/C CRU who submitted that complaint No. PW2022-10279 dated 13.05.2022 has already been transferred to SDPO/South-West on 03.08.2023. Accordingly, RTI application was again transferred

to CPIO/South-West vide letter No. 241/CPIO/Hqrs/Online RTI-23/D-172 dated 08.08.2023 under intimation to the appellant.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South-West vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought information on 03 points regarding Complaint bearing No. PW202210279 dated 13.05.2022 i.e. action taken upon complaint, copy of statements taken and copy of rules for disposal of complaints by Chandigarh Police etc.

In reply, CPIO/Hqrs informed the appellant that his RTI application was transferred to CPIO/South-West as complaint No. PW202210279 dated 13.05.2022 has already been sent to SDPO/South-West for further enquiry.

Thereafter, CPIO/South-West had denied the requisite information to the appellant u/s 8(1)(h) of RTI Act as the aforementioned complaint was under consideration/enquiry at that stage.

So far as the appeal is concerned, the information with regard to point Nos. 1 & 2 i.e. action taken on complaint and copy of statements taken, cannot be provided at this stage also as the complaint No. PW2022-10279 dated 13.05.2022 is still under consideration for finalization. Further, information in connection with point No. 3 i.e. copy of rules for disposal of complaints by Chandigarh Police, appellant has already been apprised that disposal of complaints is being done according to the provisions of Right to Service Act and copy of the same can be obtained from the official website of Chandigarh Administration.

Moreover, CPIO/South-West is hereby directed to provide the sought information w.r.t. point nos. 1 & 2 to the appellant in accordance with RTI act as and when the complaint in question is finalized and if no case FIR is registered on the complaint in question.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
