DECISION:-

Insofar as appeal is concerned, it is clear from the record of Public Window that complaint in question i.e. PW No. PW 202115539 is still under consideration; therefore, requisite information cannot be supplied at this stage. Hence, CPIO/South had appropriately denied the requisite information u/s 8(1) (h) of RTI Act. Accordingly, appeal stands disposed of.
