**ORDER**

The appellant has preferred 1<sup>st</sup> appeal dated 23.09.2024 against the disposal of his RTI application dated 23.08.2024 by CPIO/East with the contentions that requisite information was not provided to him.

**Information sought vide RTI application :-**

The appellant vide his RTI application has sought information on 06 points i.e. action taken report on DDR No. 12 dated 08.10.2016 registered at PS-26, Chandigarh, details, facts, records etc regarding DDR No. 12 dated 08.10.2016 registered at PS-26, Chandigarh, copy of complaints filed by me and against me (Munesh) in Chandigarh Police, documents/information regarding compliant no. ICMS/2024/004295 on which basis I was declared a habitual complainer, detail information on the official duties and protocols needs to be followed by IO in complaint no. ICMS/2024/004295 and information of any negligence found in protocol and duties followed by IO in complaint no. ICMS/2024/004295.

**COMMENTS OF CPIO/East:-**

CPIO/East vide his comments submitted that RTI application was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from SHO PS-26 and point wise reply was provided to the applicant vide no. 174-RTI/CPIO/East dated 20.09.2024.

**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought information on 06 points i.e. action taken report on DDR No. 12 dated 08.10.2016 registered at PS-26, Chandigarh, details, facts, records etc regarding DDR No. 12 dated 08.10.2016 registered at PS-26, Chandigarh, copy of complaint filed by me and against me (Munesh) in Chandigarh Police,

declared a habitual complainer, detail information on the official duties and protocols needs to be followed by IO in complaint no. ICMS/2024/004295 and information of any negligence found in protocol and duties followed by IO in complaint no. ICMS/2024/004295.

Now, as far as the appeal is concerned, information regarding points no. 1 & 2, has already been provided to the appellant by CPIO/East. Hence, no action is required to be taken on these points.

Information pertaining to point no. 03, CPIO/East has apprised that all the complaints are now consigned with HAC Branch. However, applicant has sought only copy of the complaint which can be provided to the appellant. Therefore, CPIO/East is hereby directed to provide the copy of the complaint to the applicant as per the provisions of RTI Act.

Moreover, information on points no. 04, 05 & 06, CPIO/East has inappropriately disposed of the RTI application on these points without going through the points. However, no action is required to be taken on these points as appellant has raised queries/questions for enquiry of the complaint, which is not entertainable under RTI Act and falls outside the purview of section 2(f) of RTI Act.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
