## **ORDER**

The appellant has preferred 1<sup>st</sup> appeal through online RTI portal vide No. PODEP/A/E/22/00121 dated 18.10.2022 against the disposal of his RTI application bearing No. PODEP/R/E/22/00739 dated 22.09.2022 by CPIO/Central with the contentions that requisite information was not supplied to him.

# Information sought vide RTI application:

The appellant vide his RTI application dated 22.09.2022 had sought CFSL report against complaint no. 2019-19815 dated 16.10.2019 and also asked for how many signatures have been sent for examination.

## Comments of CPIO/Central:-

CPIO/Central vide his comments submitted that RTI application of the appellant was received in his office through online RTI portal vide No. PODEP/R/E/22/00739 dated 22.09.2022. Thereafter, requisite information was sought from SHO PS Sector 17, Chandigarh who reported that complaints bearing No. 2019-19815 dated 16.10.2019 was pending under enquiry. However, no specimen signatures as well as documents were sent to CFSL, Sector 36 for examination, hence the required information could not be supplied. The applicant was informed accordingly vide letter no. 265/RTI-22/CPIO-Central dated 12.10.2022.

### Decision:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that at the time of disposing of the RTI application of the appellant, complaint bearing No. 2019-19815 dated 16.10.2019 was pending under enquiry and no specimen signatures as well as documents were sent to CFSL, Sector 36 for examination, hence the required information could not be supplied.

As the available information has already been supplied by CPIO/Central, therefore, no more action is required to be taken on the instant appeal. However, appellant has raised his grievances in the instant appeal which cannot be redressed under RTI act, so, he is hereby advised to approach appropriate authority for redressal of his grievances.

With these observations/directions, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
