## ORDER

appeal appellant has preferred 1 st PODEP/A/E/21/00078 dated 27.09.2021) against the reply of CPIO/Central in connection with RTI application (bearing No. PODEP/R/E/21/00472 dated 19.08.2021) with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide No. 102/UT/RTI/FAA/SSP dated 27.09.2021 for further proceeding under RTI Act.

# INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information on 04 points regarding videography and photography done by Police Station 03, Chandigarh for her house on 14.08.2021.

## COMMENTS OF CPIO/Central: -

CPIO/ Central submitted that appellant information vide his online RTI application. Thereafter, the requisite information was obtained from SHO-03, who reported that no videography or photography was done by Police Station 03 on dated - 14.08.2021 of the said house but videography that was attached with RTI application is Video sent by her on mail and videography done by Chandigarh Police vide DDR No.07 on 16.04.2021 which was supplied to applicant vide No. 307/RTI-21/CPIO-Central/UT/dated Chandigarh the 13.09.2021.

#### **DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought information on 04 points regarding videography and photography done by Police Station 03, Chandigarh of her house on 14.08.2021

Insofar appeal is concerned, appellant has sought videography/photography of her house done by Chandigarh Police on 14.08.2021. In reply of this, CPIO/Central mentioned that no such videography/photography of her house was done by PS-03 on 14.08.2021, however, CPIO has supplied videography which was done by PS-03 on 16.04.2021. In view of above, CPIO/Central is directed to provide an opportunity to the appellant to inspect the available record and provide the requisite available information in record with him. Appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
