ORDER

The appellant has preferred her 1st appeal dated 07.10.2024 against the disposal of her RTI application dated 27.08.2024 by CPIO/Admn with the contentions that requisite information was not provided to her.

Information sought vide RTI application :-

The appellant vide her RTI application had sought information regarding complaint no. ICMS/2024/020327 i.e. copy of complaint, copy of statements etc.

COMMENTS OF CPIO/Admn.:-

CPIO/Admn. vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from concerned I/C CRU who reported that complaint in question i.e. ICMS/2024/020324 is under consideration. Hence, sought information was denied to the appellant as per the provisions of section 8 (1) (h) of RTI Act and applicant was apprised vide letter no. 159/RTI/DSP/Admn. dated 16.09.2024.

DECISION :-


I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide her RTI application had sought information regarding complaint no. ICMS/2024/020327 i.e. copy of complaint, copy of statements etc.

In reply, CPIO/Admn. has denied the sought information to the appellant as per the provisions of section 8 (1) (h) of RTI Act.

Now as far as appeal is concerned, complaint in question is still under consideration. Hence, sought information cannot be provided at this stage also. However, appellant has also sought copy of the complaint and the same can be provided to the appellant. Therefore, CPIO/Admn is hereby directed to provide the copy of the complaint, to the appellant as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
