#### ORDER

The appellant has preferred his 1<sup>st</sup> appeal dated 06.10.2024 against the disposal of his RTI application dated 04.09.2024 by CPIO/Admn with the contentions that requisite information was not provided to him.

### Information sought vide RTI application :-

The appellant vide his RTI application had sought information on 05 points i.e. certified copy of complaint ICMS/2022/014507, copy of all statements, name of inquiry officer, status of complaint and copy of final enquiry report.

## COMMENTS OF CPIO/Admn:-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Accordingly, requisite information was obtained from I/C HAC, who reported that Complaint in question is consigned with HAC Branch. Accordingly, appellant was contacted, wherein he requested to send the requisite information through post. After receiving the requisite fee, information was provided to the appellant in the shape of 46 pages vide no. 144/CPIO/Admn, RTI-24 dated 01.10.2024.

#### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant had sought information on 05 points i.e. certified copy of complaint ICMS/2022/014507, copy of all statements, name of inquiry officer, status of complaint and copy of final enquiry report.

In reply, CPIO/Admn has already provided the sought information to the appellant in the shape of 46 pages.

Now as far as appeal is concerned, CPIO/Admn has already provided the sought information to the appellant. Hence, no more action is required to be taken.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
