**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal dated 19.10.2024 against the disposal of his RTI application dated 01.09.2024 by CPIO/Admn with the contentions that requisite information was not provided to him.

**Information sought vide RTI application :-**

The appellant vide his RTI application dated 01.09.2024 had sought information on 03 points regarding action report on PMOPG/E/2024/0134221 i.e. commercial utilization of biological resources from UT, Chandigarh Biodiversity Board, performing animals from UT Chandigarh Animal Welfare Board and permission to protest in front of Rock Garden.

**COMMENTS OF CPIO/Admn:-**

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, after obtaining requisite information from concerned point wise reply was provided to the appellant and applicant was apprised vide no. 300/RTI-24/CPIO/Admn dated 08.10.2024.

**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 03 points regarding action report on PMOPG/E/2024/0134221 i.e. commercial utilization of biological resources from UT, Chandigarh Biodiversity Board, performing animals from UT Chandigarh Animal Welfare Board and permission to protest in front of Rock Garden.

In reply, concerned CPIO/Admn has provided the available sought/requisite information with them to the appellant.

Now as far as appeal is concerned, appellant is not satisfied with the information provided to him. However, CPIO/Admn have appropriately disposed off the RTI application by providing the available information to the appellant. Hence, no more action is required to be taken on this instant 1<sup>st</sup> appeal as requisite information has already been provided to the appellant.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
