ORDER

The appellant has preferred 1st appeal dated 28.10.2022 against the disposal of his RTI application dated 28.09.2022 by CPIO/PHQ with the contentions that requisite information has been declined to him.

Information sought vide RTI application:

The appellant vide his RTI application dated 28.09.2022(submitted through authorized person Sachin Gautam S/o Daya Parkash) had sought current status and copy of complete file of complaint bearing PWS No. 2022-07526.

Comments of CPIO/PHQ:-

CPIO/PHQ vide his comments submitted that RTI application of the appellant was received in his office through CAPIO/PHQ on 28.09.2022. Thereafter, requisite information was sought from I/C CRU branch who reported that complaint bearing PWS No. 2022-07526 was under consideration with senior officer and information sought by the appellant was denied u/s 8(1)(h)of RTI act vide letter No. 578/CPIO/Hqrs/RTI-2022,D-849, dated 07.10.2022.

So far as present status of complaints bearing PWS No. 2022-07526 is concerned, the same is still under consideration.

Decision:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/PHQ vis-à-vis material available on record which revealed that at the time of disposing of the RTI application of the appellant, complaints bearing PWS No. 2022-07526 was pending under consideration, hence, information pertaining to this complaint was rightly denied by CPIO/PHQ.

Now, as per office record, enquiry into this complaint is yet to be finalized. Therefore, to uphold the spirit of RTI act as well as for the satisfaction of the appellant, CPIO/PHQ is hereby directed to supply the requisite information to the appellant as and when enquiry into this complaint is finalized, if the same is not exempted under RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
