**ORDER**

The appellant has preferred 1<sup>st</sup> appeal bearing No. (PODEP/A/E.21/00081) against the reply/order of CPIO/ East in connection with his RTI application bearing No.(PODEP/R/E/21/00547) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 107/UT/RTI/FAA/SSP dated 09.10.2021 for further proceeding under RTI Act.

**INFORMATION SOUGHT IN RTI APPLICATION:-**

The appellant had sought information on 8 points pertaining to FIR No. 43 dated 15.03.2021 PS-I/A and he has only objection with regard to point No. 05.

**COMMENTS OF CPIO/EAST: -**

CPIO/East submitted that appellant has sought information regarding FIR No. 43/2021 PS-Ind. Area. Thereafter, report from SHO-Ind. Area was received who submitted that point was reply was prepared and supplied to appellant on 08.10.2021. Now, appellant has contentions in regard


with point no. 05 only i.e. gender of the police official Male/Female who attended the spot in civil uniform as per record. Now, SHO PS-I/A has reported that lady police official attended the spot in civil uniform.

**DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/ East vis-à-vis material available on record which revealed that appellant has only objection with regard to point No. 05.

Insofar appeal is concerned, appellant is unsatisfied with the information supplied on point No. 5 and he wants total no. police officials (male or female) who attended the spot in civil cloths. Hence, SDPO/East is hereby directed to supply the same to appellant. Appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
