ORDER

The appellant has preferred his 1st appeal dated 18.12.2024 against the disposal of his RTI application dated 17.10.2024 by CPIO/Admn & South with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application dated 17.10.2024 had sought information on 04 points i.e. certified copy of complaint along with all record of complaint bearing no. ICMS/2022/012623, certified copy of complaint along with all record in respect to departmental enquiry no. 130-47/UT/RD/Des Centralized/SSP, certified copy of complaint along with all record of complaint bearing no. ICMS/2024/013424 and certified copy of complaint along with all record of complaint bearing no. ICMS/2024/016248.

COMMENTS OF CPIO/Admn:-

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from I/C HAC, I/C CRU and I/C DE Branch and the same was supplied to the applicant vide no. 364 & 415/RTI/DSP/Admn dated 27.11.2024.

COMMENTS OF CPIO/South:-

CPIO/South vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from SHO-31, who reported that complaint in question ICMS/2024/016248 is still under consideration. Hence, the same was denied as per the provisions of section 8 (1) (h) of RTI Act. Further, remaining information was transferred to CPIO/Admn vide no. 273/RTI-24/CPIO-South dated 23.11.2024 and applicant was apprised about the same, accordingly.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn & South vis-à-vis material available on record which revealed that

the appellant vide his RTI application had sought information on 04 points i.e. certified copy of complaint along with all record of complaint bearing no. ICMS/2022/012623, certified copy of complaint along with all record in respect to departmental enquiry no. 130-47/UT/RD/Des Centralized/SSP, certified copy of complaint along with all record of complaint bearing no. ICMS/2024/013424 and certified copy of complaint along with all record of complaint bearing no. ICMS/2024/016248.

In reply, CPIO/Admn & South have already provided point wise information to the applicant.


As far as the appeal is concerned, information pertaining to point nos. 01 & 03 (certified copy of complaint along with all record of complaint bearing no. ICMS/2022/012623 and certified copy of complaint along with all record of complaint bearing no. ICMS/2024/013424), CPIO/Admn has already provided the requisite information to the applicant in the shape of 23 pages to the applicant.

Information pertaining to point no. 04 (certified copy of complaint along with all record of complaint bearing no. ICMS/2024/016248), CPIO/South has appropriately denied the requisite information as complaint in question is still under consideration.

Further, information pertaining to point no. 02, (certified copy of complaint along with all record in respect to departmental enquiry no. 130-47/UT/RD/Des Centralized/SSP), CPIO/Admn has appropriately denied the requisite information as the same is still under consideration. Hence, denied as per the provisions of section 8 (1) (h) of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
