ORDER

The appellant has preferred 1st appeal dated 29.10.2022(received on 07.11.2022) against the disposal of his RTI application dated 24.08.2022 by CPIO/East with the contentions that requisite information has not been provided to him.

Information sought vide RTI application:

The appellant vide his RTI application dated 24.08.2022 had sought information on 5 points in question form pertaining to complaint bearing PWS No.2022-07500 dated 08.04.2022.

Comments of CPIO/East :-

CPIO/East vide his comments submitted that RTI application of the appellant was received in his office through CPIO/Traffic Admn. on 27.08.2022 for supplying information pertaining to a complaint bearing PWS No.2022-07500 dated 08.04.2022 made by Mr. Sukhpreet Singh against the applicant Vinod Kumar. As the complaint in question was already sent to senior officers for finalization, so RTI application of the appellant was transferred to CPIO/PHQ u/s 6(3) of RTI Act (under intimation to the appellant) for supplying the requisite information on 30.08.2022, as per RTI Act.

Comments of CPIO/PHQ:-

To proceed further in the matter, comments of CPIO/PHQ was also sought, who submitted that RTI application of the appellant was received in his office through CPIO/East on 30.08.2022 for supplying information pertaining to a complaint bearing PWS No.2022-07500 dated 08.04.2022. As enquiry into this complaint was finalized and same was

consigned in HAC branch, so relevant file was called from HAC branch u/s 5(4)(5) of RTI Act. After obtaining complete file from HAC branch, appellant was informed vide letter No.519/CPIO/Hqrs/RTI-22,D-795, dated 20.09.2022 to inspect the relevant file/record and collect requisite information from his office.

Decision:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East and CPIO/PHQ vis-à-vis material available on record which revealed that on receiving RTI application of the appellant, CPIO/East found that complaint bearing PWS No.2022-07500 dated 08.04.2022 has already been sent to police headquarters for finalization, so RTI application of the appellant was rightly transferred to CPIO/PHQ by CPIO/East under intimation to the appellant. Furthermore, CPIO/PHQ, after obtaining the relevant file from HAC branch, vide letter dated 20.09.2022 informed the appellant to collect the requisite information from his office after inspecting the file but appellant did not come up to collect the same, so far.

As vide letter dated 20.09.2022,appellant has already been called by the CPIO/PHQ for obtaining the requisite information from his office, after inspecting the relevant file, hence, there is neither any delay nor any denial on the part of any of the CPIOs. So far as the grievances raised by the appellant in his 1st appeal, are concerned, these are not maintainable under RTI act. Appellant is hereby advised to approach the office of CPIO/PHQ for obtaining the requisite information after inspecting the relevant file.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
