ORDER

The appellant has preferred her 1st appeal dated 02.10.2024 against the disposal of her RTI application dated 07.09.2024 by CPIO/North-East with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide her RTI application dated 07.09.2024 had sought copy of complaint and status of complaint bearing no. ICMS/2024/025213.

COMMENTS OF CPIO/N.East:-

CPIO/North-East vide his comments submitted that RTI application of the appellant was transferred in his office by CPIO/W&CSU to supply the information. Thereafter, requisite information was obtained from SHO- Mani Majra who reported that the complaint in question is has not be received in this office and applicant was apprised about the same vide letter No. 113/RTI/CPIO/North-East dated 26.09.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/North-East vis-à-vis material available on record which revealed that the appellant vide her RTI application had sought copy of complaint and status of complaint bearing no. ICMS/2024/025213.

In reply, CPIO/North-East has apprised the appellant that complaint in question is has not been received in his office from DSP/W&CSU.

So far as appeal is concerned, as per the report of CPIO/North-East, online movement of the complaint shows complaint has not been sent to DSP/North-East till date. Therefore, no more action is required to be taken on this appeal.

Moreover, appellant is also advised to liaison with the concerned CPIO, regarding the status of her complaint.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
