ORDER

The appellant has preferred 1st appeal against the reply of CPIO/East in connection with RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 108/UT/RTI/FAA/SSP dated 13.10.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information regarding Complaint No. PW 202121040 dated 17/09/2021 i.e. copy of complaint and copy of additional documents provided along with the complaint.

COMMENTS OF CPIO/East: -

sought appellant has that submitted CPIO/East information vide his RTI application. Thereafter, report from SHO/PS-ITP was obtained who reported that the sought information is still pending under enquiry. Hence, denied under 8 (1) (h) of RTI Act. The

appellant has been appraised vide no. 369/RTI/CPIO/East, dated 07.10.2021.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant had sought information regarding Complaint No. PW 202121040 dated 17/09/2021 i.e. copy of complaint and copy of additional documents provided along with the complaint.

Insofar as appeal is concerned, it is clear from the reply of CPIO/East and record of Public Window that the appellant is accused in the above said complaint in question i.e. PW 202121040 which is still under enquiry; therefore, requisite information cannot be supplied at this stage. However, for achieving the objectives of RTI Act and in the interest of justice, CPIO/East is hereby directed to supply the copy of the complaint to the appellant as per RTI Act. Accordingly, appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
