ORDER

The appellant has preferred online 1st appeal bearing No. PODEP/A/E/23/00093 dated 30.08.2023 against the disposal of his online RTI application bearing No. PODEP/R/E/23/00652/5 dated 31.07.2023 by CPIO/East with the contentions to provide him correct and complete information.

Information sought vide RTI application :-

The appellant vide his online RTI application had sought information on 03 points i.e. any police complaint/ police case filed against Arun Vohra, Ambika Vohra and Aarti Vohra R/o H. No. 5245 GF, Sector 38-West, Chandigarh, 532/1, Sector 38/A, Chandigarh, Flat No. 1230, Sector 52-D, Chandigarh and Flat No. 4837 Housing Board Society Sector 38-West, Chandigarh from January 2005 till 03 August 2023, how a family can own such a large number of flats in Chandigarh city, provide number of flat allotment authority and emergency contact number of life safety team of Chandigarh Police etc.

COMMENTS OF CPIO/EAST :-

CPIO/East vide his comments submitted that RTI application of the appellant was received in his office through online RTI portal to supply the requisite information. Thereafter, requisite information was obtained from all SHOs of East Sub Division and with regard to information of point no. 01 appellant was informed that no case or complaint was found registered against Janak Raj Vohra S/o Harnam Dass Vohra, Arun Vohra S/o Janak Raj Vohra, Ambika Vohra D/o Janak Raj Vohra and Aarti Vohra D/o Janak Raj Vohra R/o H. Nos. 41, Sector 16A, Chandigarh, 5245 GF, Sector 38-West, Chandigarh, 532/1, Sector 38/A, Chandigarh, Flat No. 1230, Sector 52-D, Chandigarh and Flat No. 4837 Housing Board Society, Sector 38-West, Chandigarh. Information related to point no. 2 was found not related to East Sub Division and information of point no. 03 was provided i.e. emergency number 112 of Police Department vide letter No. 169 & 169 A-RTI/CPIO/East dated 19.08.2023.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought information on 03 points i.e. any police complaint/ police case filed against Arun Vohra, Ambika Vohra and Aarti Vohra R/o H. No. 5245 GF, Sector 38-West, Chandigarh, 532/1, Sector 38/A, Chandigarh, Flat No. 1230, Sector 52-D, Chandigarh and Flat No. 4837 Housing Board Society Sector 38-West, Chandigarh from January 2005 till 03 August 2023, how a family can own large number of flats in Chandigarh, provide number of flat allotment authority and emergency contact number of life safety team of Chandigarh Police etc.

In reply, CPIO/East informed the appellant with regard to point no. 1 that no case or complaint was found registered against Janak Raj Vohra S/o Harnam Dass Vohra, Arun Vohra S/o Janak Raj Vohra, Ambika Vohra D/o Janak Raj Vohra and Aarti Vohra D/o Janak Raj Vohra R/o H. Nos. 41, Sector 16A, Chandigarh, 5245 GF, Sector 38-West, Chandigarh, 532/1, Sector 38/A, Chandigarh, Flat No. 1230, Sector 52-D, Chandigarh and Flat No. 4837 Housing Board Society, Sector 38-West, Chandigarh. Information related to point no. 2 was found not related to East Sub Division and information of point no. 03 was provided i.e. emergency number 112 of Police Department.

So far as the appeal is concerned, available information in pointwise form was provided to the appellant by CPIO/East. So, no more action is warranted in the matter.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
