ORDER

The appellant has preferred her 1st appeal dated 23.09.2024 against the disposal of her RTI application dated 02.08.2024 by CPIO/Admn with the contentions that requisite information was not provided to her.

Information sought vide RTI application :-

The appellant vide her RTI application had sought complete proceedings/file of complaints bearing no. ICMS/2023/014529, ICMS/2023/009382 & ICMS/2023/012922.

COMMENTS OF CPIO/Admn :-

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from I/C HAC who reported that complaints in question are now consigned with HAC Branch. Accordingly, appellant was informed telephonically as well as through letter to collect the same after inspection. However, applicant is yet to visit the office of CPIO/Admn to collect the same.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide her RTI application had sought complete proceedings/file of complaints bearing no. ICMS/2023/014529, ICMS/2023/009382 & ICMS/2023/012922.

In reply, CPIO/Admn has requested the appellant to visit his office to collect the requisite information after inspecting the relevant file.

Now as far as the appeal is concerned, CPIO has appropriately disposed of the RTI application. However, appellant has raised contentions that access to the record was not provided to her. Therefore, to achieve the objective of the RTI Act and for the satisfaction of the appellant, appellant is hereby again requested to visit the

office of the CPIO/Admn to inspect the file and collect the requisite information as per the RTI Act.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
