ORDER

The appellant has preferred 1st appeal (bearing No. PODEP/A/E/21/00084 dated 18.10.2021) against the reply of CPIO/East in connection with RTI application (bearing No. PODEP/R/E/21/00577 dated 05.10.2021) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 112/UT/RTI/FAA/SSP dated 18.10.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought copy of mail sent from maid idchaudhary937@gmail.com on 27.09.2021 at 3.38 PM to DSP South.

COMMENTS OF CPIO/South: -

CPIO/South submitted that appellant has sought information vide his RTI application. From the perusal of record/e-mail of SDPO, no mail record has been found in this regard. Hence, nil

report may be considered please. The appellant has been apprised through mail vide no. 526/CPIO/South, dated 14.10.2021.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought copy of mail sent from maid id- chaudhary937@gmail.com on 27.09.2021 at 3.38 PM to DSP South.

Insofar as appeal is concerned, it is clear from the reply of CPIO/South that no such mail has been received in the office of the SDPO/South and appellant has been appraised about the same. However, for achieving the objectives of RTI Act and in the interest of justice, CPIO/Central is directed to examine relevant record thoroughly and provide the requisite available information in record, if available as per RTI Act. Appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
