**ORDER**

The appellant has preferred 1<sup>st</sup> appeal against the reply/order of CPIO/Central in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 145/UT/RTI/FAA/SSP dated 20.12.2021 for further proceeding under RTI Act.

**INFORMATION SOUGHT IN RTI APPLICATION:-**


Appellant had sought information on 04 points relating to Complaint bearing no. PW 202125218 i.e. copy of counseling done at women and child cell, final report of complaint, copy of complaint filed by Dr. Puneet against me at PP-PGI and Copy of DDR registered against said complaint.

**COMMENTS OF CPIO/Central: -**

CPIO/Central submitted that application of the appellant was received online for supplying requisite information. Required information was obtained from SHO-11, who submitted that point nos. 01 & 02 relates to Women and Child Unit and as far as point no. 03 & 04 are concerned consent from Dr. Puneet Singhal was obtained telephonically who gave in writing that his information should not be disclosed to anyone. Hence the requisite information was denied u/s 8 (1) (j) of RTI Act, being third party information. Appellant has been apprised vide memo no. 424-425/CPIO/Central dated 09.12.2021.

**DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record




which revealed that appellant had sought information on 04 points relating to Complaint bearing no. PW 202125218 i.e. copy of counseling done at women and child cell, final report of complaint, copy of complaint filed by Dr. Puneet against me at PP-PGI and Copy of DDR registered against said complaint.

Insofar as appeal is concerned with point no. 01-02, appellant has sought information regarding complaint no. PW-202125218, which related with the unit of Women and child. From perusal of reply of CPIO/Central it is clear that RTI application was not transferred to concerned branch, which should have been done in the first place by the CPIO. Now, in order to mend the ways, CPIO/Central is hereby directed to transfer the RTI application immediately to CPIO/W&CSU without wasting any time.

With regard to point nos. 03 & 04, it is clear that appellant is the alleged party in the said complaint. Therefore, requisite information cannot be denied u/s 8 (1) (j) of RTI Act. Hence, CPIO/Central is hereby directed to supply the information related to point no. 03 & 04 as per RTI Act.

With these directions, appeal stand disposed off.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
