ORDER

The appellant has preferred his 1st appeal dated 16.01.2024 against the disposal of his RTI application dated 15.12.2023 with the contentions that requisite information was not supplied to him..

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought information on 09 points i.e. List of vehicles alongwith FIR copy of vehicles involved in accidents & outstation permission and Driving License of drivers, copy of proceedings sent to mobile no. of SHO-39, copy of proceedings regarding vehicle no. PB01C7454 sent to mobile no. of SHO-39, copy of complaints bearing no. PW 201907605, ICMS-2020/016713, ICMS/2011/09441, ICMS/2022/013151, ICMS/2023/017817 & PW 2015-12258, list of police officials who have gone under commando training alongwith their posting details, list of police officials who are not transferred even after completion of their tenure, copy of Police Verfication report of all PGs/tenants of sector 38 & 37, copy of reply sent to SC/ST Commisson regarding Mukest R/o Sector 38-A, Chandigarh and CCTV footage of PS-39 from 03:00 AM to 06:00 PM of dated 13.12.2023.

COMMENTS OF CPIO/South: -

CPIO/South submitted that RTI application of the appellant was received to supply the requisite information. Accordingly, report from concerned SHOs were obtained and only compliant bearing no. ICMS/2023/017817 was found related with PS-49 and the same is still under enquiry; therefore, the same cannot be supplied at that stage. Appellant was apprised about the same vide No. 299/RTI-23/CPIO-South/Chandigarh Dated 15.01.2024.

COMMENTS OF CPIO/East: -

CPIO/East submitted that RTI application of the appellant was received to supply the requisite information. From the perusal of RTI application, sought information was not found related with this office. RTI application has already been transferred to concerned

CPIOs by Nodal officer, so, no more action is required to be taken on this RTI application. Accordingly, RTI application is hereby filed.

COMMENTS OF CPIO/Lines: -

CPIO/Lines submitted that RTI application of the appellant was received to supply the requisite information. Accordingly, report from concerned MT Section was obtained who reported that only point no. 1 was found related with Police Lines. Hence, list of FIRs registered on accident vehicles is attached and copy of Out Station Permission & copy of driving licence of drivers are denied as per the provisions of section 8 (g & j) of RTI Act, information being personal in nature. Appellant was apprised about the same vide No. 01/RTI-24/DSP-Lines (CPIO), dated, Chandigarh the: 11.01.2024.

COMMENTS OF CPIO/Central: -

CPIO/Central submitted that RTI application of the appellant was received to supply the requisite information. From the perusal of RTI application, sought information was not found related with this office. RTI application has already been transferred to concerned CPIOs by Nodal officer, so, no more action is required to be taken on this RTI application. Accordingly, RTI application is hereby filed.

COMMENTS OF CPIO/Hqrs:-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received to provide the requisite information. Accordingly, requisite information was obtained from HAC, who reported that complaints upto 2011 and 2015 has already been destroyed vide no. 17810/UT/E-6 dated 07.04.2014 and 6840-80/UT/HAC dated 17.09.2019 respectively. Complaint bearing no. 2022/013151 is found consigned with HAC Branch after the finalization of the enquiry. However, complaint is not found directly related with the appellant. Hence, appellant was directed to provide proper authority letter in his favour to obtain the requisite information. Appellant was apprised about the same vide no. 728/VPIO/Hqrs./RTI-2023 D-44 dated 08.01.2024.

COMMENTS OF CPIO/North-East: -

CPIO/North-East submitted that RTI application of the appellant was received to supply the requisite information. Accordingly, report from concerned SHOs were obtained and only compliant bearing no. 2022/013151 was found related with PS-Mauli Jagran and the same has already been sent to senior officers. Appellant was apprised about the same, accordingly.

COMMENTS OF CPIO/South-West :-

CPIO/South-West vide his comments submitted that RTI application of the appellant was received to provide the requisite information. Accordingly, requisite information was obtained from concerned SHOs and pointwise reply was provided to the appellant vide no. 309-RTI/CPIO/South West/Dated, Chandigarh.

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIOs vis-à-vis material available on record which revealed that appellant had sought information on 09 points i.e. List of vehicles alongwith FIR copy of vehicles involved in accidents & outstation permission and Driving License of drivers, copy of proceedings sent to mobile no. of SHO-39, copy of proceedings regarding vehicle no. PB01C7454 sent to mobile no. of SHO-39, copy of complaints bearing no. PW 201907605, ICMS-2020/016713, ICMS/2011/09441, ICMS/2022/013151, ICMS/2023/017817 & PW 2015-12258, list of police officials who have gone under commando training alongwith their posting details, list of police officials who are not transferred even after completion of their tenure, copy of Police Verfication report of all PGs/tenants of sector 38 & 37, copy of reply sent to SC/ST Commisson regarding Mukest R/o Sector 38-A, Chandigarh and CCTV footage of PS-39 from 03:00 AM to 06 PM of dated 13.12.2023.

Insofar appeal is concerned, information regarding point no. 1 (. List of vehicles alongwith FIR copy of vehicles involved in accidents & outstation permission and Driving License of drivers), CPIO/Lines has provided partial requisite information to the appellant and rest of the information has been denied, appropriately, as per the provisions of section 8 (1) (g & j) of RTI Act.

Information on point nos. 2-3 i.e. copy of proceedings sent to mobile no. of SHO-39, copy of proceedings regarding vehicle no. PB01C7454 sent to mobile no. of SHO-39 etc. In this regard, CPIO/South-West has informed the appellant that no such complaint has been received on whatsapp.

Moreover, information pertaining to point no. 4 i.e. copy of complaints bearing no. PW 201907605, ICMS-2020/016713, ICMS/2011/09441, ICMS/2022/013151, ICMS/2023/017817 & PW 2015-12258. CPIO/Hqrs has apprised the appellant that complaints upto 2011 and 2015 has already been destroyed vide no. 17810/UT/E-6 dated 07.04.2014 and 6840-80/UT/HAC dated 17.09.2019 respectively. As far as complaints no. 2022/013151, 2023/013151 & 2020/016713 are concerned, these are not directly related with the appellant. Hence, it attracts section 8(1) (j) of RTI Act.

Now, as per the record of ICMS portal complaints bearing no. 2019/017605 is still pending with SDPO/South. Therefore, CPIO/South are directed to provide the requisite information to the appellant strictly as per the provisions of RTI Act.

Moreover, information pertaining to points No. 7 & 8 i.e. copy of Police Verfication report of all PGs/tenants of sector 38 & 37, copy of reply sent to SC/ST Commisson regarding Mukest R/o Sector 38-A, has been denied by CPIO/South-West to the appellant as per the provisions of section 8 (1) (j) of RTI Act, as sought information is third party information and no larger public interest would be served by disclosing such information to the appellant.

On point No. 10, appellant has sought CCTV footage of PS-39 dated 13.12.2023 from 03:00AM to 09:00PM. CPIO/South-West has denied the sought information as per the

provisions of section 8 (1) (g) & (j) of RTI Act, as sought information is third party information and providing such information may endanger the life and liberty.

Moreover, appeal regarding points no. 5 & 6 has already been transferreed to SP/Hqrs vide no. D-17/UT/RTI/FAA/SSP dated 18.01.2024 as RTI application was already trnaferred to the concerned by CAPIO.

With these directions, the instant appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
