## ORDER

## Order on First Appeal u/s 19 RTI Act.

This is an order on an appeal preferred by Sh. Satish Kumar R/o # 4255, Sector-46 D, Chandigarh under RTI Act 2005, received in this office on 29.04.2022, against the disposal of his online RTI Application by DSP-HQs-cum-CPIO/Establishment, vide No. 38/RTI-22/CPIO (Estt.)/UT/17331 dated 30.03.2022.

- (2) The appellant, vide his application dated 08.03.2022 under RTI Act 2005, had requested CPIO/PHQ to supply him some information in 07 points regarding order No. 19838-60/UT/UT/E-II dated 26.06.2020. CPIO/Establishment disposed of the RTI application on 30.03.2022.
- (3) The appellant not satisfied with the manner CPIO/Estt. has disposed of the RTI application, has filed the instant appeal against point No. 01, 06 and 07 requesting therein to provide complete information.
- (4) Comments of CPIO/Establishment have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Establishment. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-
