ORDER

The appellant has preferred this instant 1st appeal dated 16.10.2024 against the disposal of his RTI application dated 13.09.2024 by CPIO/Admn with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application had sought information 04 points i.e. certified copy of complaint no. ICMS/2024/019355, certified copy of complaint no. ICMS/2024/019995, certified copy of complaint no. ICMS/2024/020010 and certified copy of complaint no. ICMS/2023/006821.

COMMENTS OF CPIO/Admn :-

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office to supply the requisite information. Thereafter, requisite information was sought from I/C CRU and I/C HAC. Accordingly, I/C HAC reported that information sought in regard with complaint no. ICMS/2023/006821 is personal in nature and third party. Hence, the same was denied to the appellant as per the provisions of section 8 (1) (j) of RTI Act and I/C CRU reported that the complaints bearing no. ICMS/2024/019355, ICMS/2024/019995 & ICMS/2024/020010 are still under inquiry. Hence, the sought information was denied to the appellant as per the provisions of section 8(1) (h) of RTI Act. Applicant was apprised about the same vide no. 187/RTI/DSP/Admn dated 21.10.2024.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 04 points i.e. certified copy of complaint no. ICMS/2024/019355, certified copy of complaint no. ICMS/2024/020010 and certified copy of complaint no. ICMS/2023/006821.

Now, as far as appeal is concerned, information regarding point no. 01, 02 & 03 (certified copy of complaint no. ICMS/2024/019355, certified copy of complaint no. ICMS/2024/020010), CPIO/Admn has appropriately disposed of the RTI application as complaints in question are under enquiry and the same cannot be provided to the applicant as per the provisions of section 8 (1) (h) of RTI Act. Hence, no action is required to be taken on these points.

Information in respect with point no. 04 i.e. certified copy of complaint no. ICMS/2023/006821, CPIO/Admn has appropriately denied the requisite information u/s 8(1) (j) of RTI Act, as information being third party and personal in nature. Hence, no more action is required to be taken upon this point.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
