**ORDER**

The appellant has preferred 1<sup>st</sup> appeal (bearing No. PODEP/A/E/21/00090 dated 01.11.2021) against the reply/order of CPIO/South in connection with his RTI application (bearing No. PODEP/R/E/21/000574 dated 01.10.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 120/UT/RTI/FAA/SSP dated 01.11.2021 for further proceeding under RTI Act.

**INFORMATION SOUGHT IN RTI APPLICATION:-**

Appellant had sought status, action taken report, Name of IO & No. of days required to complete reply pertaining to memo marked to SHO-34 from SDM South vide Endst. No. SDM/SDA/2021/4269 dated 29.06.2021.

**COMMENTS OF CPIO/South: -**

CPIO/South submitted that application of the appellant was received online for supplying requisite information. After obtaining the requisite information from SHO-34, requisite information was denied u/s 8(1)(h) of RTI Act as complaints in question is still under enquiry.

**DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought status, action taken report, Name of IO & No. of days required to complete reply pertaining to memo marked to SHO-34 from SDM South vide Endst. No. SDM/SDA/2021/4269 dated 29.06.2021.

Insofar as appeal is concerned, it is clear that complaints in question are still under consideration, therefore, requisite information cannot be supplied at this stage, hence, CPIO/South had appropriately denied the requisite information u/s 8(1)(h) of RTI Act. However, CPIO/South is hereby directed to apprise about the current status and name of IO who is investigating the above said complaint, accordingly, appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
