## ORDER

The appellant has preferred his 1<sup>st</sup> appeal dated 30.01.2024 against the disposal of his RTI application dated 01.12.2023 by CPIO/Hqrs & Central with the contentions that requisite information was not provided to him.

## Information sought vide RTI application :-

The appellant vide his RTI application dated 01.12.2023 had sought information regarding status of FIR registered on complaint bearing no. ICMS/2023/029011 lodged by him.

#### COMMENTS OF CPIO/East:-

CPIO/East vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from SHO- Ind. Area, who reported that complaint was sent to senior officers after inquiry. Further, as per the record, complaint was dealt by PS-31 and presently, the same is now consigned with HAC Branch. Appellant was apprised about the same vide no. 62 + 62A-RTI/CPIO/East dated 15.05.2024.

#### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information regarding status of FIR registered on complaint bearing no. ICMS/2023/029011 lodged by him.

Now as far as appeal is concerned, CPIO/East has inappropriately disposed of the RTI application, without going through the contents of the RTI application. Now, the complaint bearing no. 2023/029011 has been consigned with HAC Branch after the finalization of the enquiry. Therefore, CPIO/East is hereby directed to provide the requisite information to the appellant as per RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
