ORDER

The appellant has preferred her 1st appeal dated 28.10.2024 against the disposal of her RTI application dated 08.09.2024 by CPIO/Admn with the contentions that requisite information was not provided to her.

Information sought vide RTI application :-

The appellant vide her RTI application had sought information of complaint bearing no. PW 2021-15513 dated 16.07.2021: Copy of any evidence from the opposite party of taken back jewellery and deposited with the report.

COMMENTS OF CPIO/Admn :-

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from I/C HAC, who supplied the sought information and the same was sent to the appellant through registered post vide office letter no. 155/RTI-24/DSP/Admn(O/o/SSP/UT) dated 28.10.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide her RTI application had sought information of complaint bearing no. PW 2021-15513 dated 16.07.2021: Copy of any evidence from the opposite party of taken back jewellery and deposited with the report.

In reply, CPIO/Admn has already provided the sought information to the appellant through registered post vide office letter no. 155/RTI-24/DSP/Admn(O/o/SSP/UT) dated 28.10.2024.

Now as far as appeal is concerned, CPIO/Admn has already provided the sought information to the appellant in the shape of 02 pages. However, considering the contentions of the applicant, CPIO/Admn is hereby directed to provide opportunity of the

inspection of record to the appellant and provide the requisite information as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
