### **ORDER**

The appellant has preferred online1<sup>st</sup> appeal bearing No. PODEP/A/E/23/00107 dated 19.09.2023 against the disposal of his online RTI application bearing No. PODEP/R/E/23/00638 dated 27.07.2023 by CPIO/Hqrs with the contentions that requisite information was not provided to him.

# Information sought vide RTI application :-

The appellant vide his RTI application dated 27.07.2023 had sought information on 04 points i.e. copy of complaint No. ICMS/2023/008870, copy of his statement, status of complaint and action taken report on complaint.

## COMMENTS OF CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to supply the requisite information regarding complaint No. ICMS/2023/008870 filed by the appellant. Thereafter, requisite information was obtained from I/C CRU who reported that complaint in question is under consideration for finalization. Hence, sought information was denied to the applicant as per provisions of section 8(1)(h) of RTI Act, 2005 vide letter No. 239/CPIO/Hqrs/Online/RTI-2023/D-185 dated 18.08.2023.

#### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 04 points i.e. copy of complaint No. ICMS/2023/008870, copy of his statement, status of complaint and action taken report on complaint.

In reply, CPIO/Hqrs had denied the requisite information to the appellant u/s 8(1)(h) of RTI Act as the complaints in question was under consideration at that stage.

So far as the present status of the complaint is concerned, the same is still under consideration for finalization. Hence, statement recorded and enquiry report cannot be provided at this stage also, however, copy of complaint can be provided to the appellant. Accordingly, CPIO/Hqrs is hereby directed to provide the copy of complaint to the appellant in accordance with RTI act and he is further directed to supply the action taken report or enquiry report to the appellant as per RTI act after finalization of enquiry and if no case FIR is registered on the complaint in question.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
