ORDER

The appellant has preferred 1st appeal against the reply of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to him. The appeal was diarized vide No. 123/UT/RTI/FAA/SSP dated 09.11.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant has sought copy of copy of complaints made to DGP for saving the accused Sachin Sharma, complaints made to SSP, DSP/South and PS-34 regarding FIR-143/2020 at PS-34, action taken reports, statements, call recordings, all applications made by me.

COMMENTS OF CPIO/South: -

CPIO/South submitted that appellant has sought information through RTI application. Thereafter, report of SHO/PS-34 was obtained who reported that case FIR No. 143 dated 18.07.2020 has already been sent to senior officers for consideration; therefore, requisite information cannot be disclosed u/s 8(1) (h) of RTI Act.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought copy of copy of complaints made to DGP for saving the accused Sachin Sharma, complaints made to SSP, DSP/South and PS-34 regarding FIR-143/2020 at PS-34, action taken reports, statements, call recordings, all applications made by me.

Insofar appeal is concerned, it is clear that case FIR No. 143/2020 has already been sent to concerned Illaqa Magistrate for cancellation and pending in the concerned court, so the requisite information cannot be supplied u/s 8 (1) (h) of RTI Act.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
