ORDER

The appellant has preferred his 1st appeal dated 19.08.2023 which was transferred to this office from SP/Hqrs-cum-FAA vide No. D-734-35/RTI/SP/Hqrs dated 07.09.2023 against the disposal of his RTI application dated 18.07.2023 by CPIO/East with the contentions that requisite information was not supplied to him.

Information sought vide RTI application :-

The appellant vide his RTI application dated 18.07.2023 had sought information on 09 points i.e. (j to r) but only part information of point No. (p) was found to be related with CPIO/East i.e. certified copies of all letters written by the applicant (Ms. Anju Rathi) to the department regarding her career/service like letter No. 422-5E dated 13.03.2019 PS Manimajra sent to SDPO/East.

Comments of CPIO/East :-

CPIO/East vide his comments submitted that RTI application of the appellant was received in his office for supplying the part information of point no. (p). Accordingly, requisite information was sought from SHO PS-ManiMajra who reported that letter of the appellant regarding pay fixation was sent to DSP/East for further necessary action vide No. 422-5E dated 13.03.2019. Thereafter, the same was further sent to the office of W/SSP/UT vide No. R-1703/DSP/East dated 16.03.2019. The appellant was apprised accordingly vide No. 163-RTI/CPIO/East dated 07.08.2023.

Decision :-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant had sought information on 09 points (j to r) but only part information of point No. (p) was found to be related with CPIO/East i.e. certified copies of all letters written by the applicant (Ms. Anju Rathi) to the department regarding her career/service like letter No. 422-5E dated 13.03.2019 PS Manimajra sent to SDPO/East.

In reply, CPIO/East has provided the requisite information to the appellant.

So far as the current movement of the letter in question is concerned, the requisite information has been sought from diary section which revealed that the said letter has been marked to Account Branch vide No. R- 5284/UT/Rd/SSP dated 16.03.2019.

With these observations, instant appeal stands disposed off as far as the part information of the office of the undersigned is concerned.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
