ORDER

The appellant has preferred 1st appeal through online RTI portal vide No. PODEP/A/E/22/00137 dated 19.11.2022 against the disposal of his RTI application bearing No. PODEP/R/E/22/00823 dated 18.10.2022 with the contentions that Incomplete, Misleading and False information have been provided to him.

INFORMATION SOUGHT IN RTI APPLICATION :-

The appellant vide his RTI application dated 18.10.2022 had sought information on 5 points pertaining to a complaint bearing PWS No.2020-14651 filed by him.

COMMENTS OF CPIO/Hqrs : -

Comments of CPIO/Hqrs have been obtained who submitted that RTI application of the appellant was received in his office through online RTI portal vide no. PODEP/R/E/22/00823 dated 18.10.2022. As the complaint bearing PWS No.2020-14651 was already consigned to record in HAC branch, so the same was called from I/C HAC branch and after offering inspection of the file, requisite information pertaining to this complaint was supplied to the applicant in the shape of thirty three (33) pages vide letter No. 311/CPIO/Hqrs./Online/RTI-22, dated 18.11.2022 under proper receipt.

DECISION :-


I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs. vis-à-vis material available on record which revealed that the

requisite information pertains to complaint bearing PWS No.2020-14651 has already been supplied to the appellant by CPIO/Hqrs. after inspecting the file in the shape of thirty three (33) pages vide letter No. 311/CPIO/Hqrs./Online/RTI-22, dated 18.11.2022 under proper receipt. As the available information has already been provided and RTI application of the appellant was rightly disposed off by the CPIO/Hqs, so, no action is warranted on the instant appeal.

So far as the other points raised by the appellant in his 1st appeal are concerned, appellant is hereby advised to approach the appropriate platform as this act provides a mechanism for supplying only the **available** information to the appellant which has already been supplied.

With these observations, the instant appeal stand disposed off.

However, in case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
