ORDER

The appellant has preferred 1st appeal dated 11.09.2023 against the disposal of his RTI application dated 12.07.2023 by CPIO/Hqrs with the contentions that requisite information were not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application dated 12.07.2023 had sought certified copy of complaint alongwith copy of all proceedings in complaint bearing No. ICMS/2022/013448.

COMMENTS OF CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to supply the information regarding complaint bearing No. ICMS/2022/013448. Thereafter, requisite information was obtained from I/C CRU who reported that complaint in question is under consideration for finalization. Hence, sought information was denied to the applicant as per provisions of section 8(1)(h) of RTI Act, 2005 vide letter No. 389/CPIO/Hqrs/RTI-2023, D-535 Dated 27.07.2023.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought certified copy of complaint alongwith copy of all the proceedings in respect of complaint bearing No. ICMS/2022/013448.

In reply, CPIO/Hqrs had denied the requisite information to the appellant u/s 8(1)(h) of RTI Act as the complaint in question was under consideration at that stage.

So far as the present status of the complaint is concerned, the same has now been consigned to record after completion of enquiry as per ICMS Portal. Therefore, CPIO/Hqrs is hereby directed to provide the requisite information to the appellant in accordance with RTI act.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
