## **ORDER**

The appellant has preferred 1<sup>st</sup> appeal dated 05.11.2024 against the disposal of his RTI application dated 23.10.2024 by CPIO/Central with the contentions that requisite information was not provided to him.

# Information sought vide RTI application :-

The appellant vide his RTI application dated 23.10.2024 has sought information on 02 points regarding complaint no. ICMS/2024/020348 i.e. copy of all documents & statements related to case and copy of all statements given and any other certified record pertaining to this case.

#### COMMENTS OF CPIO/Central:-

CPIO/Central vide his comments submitted that RTI application of the appellant was received in his office for supplying the requisite information. Thereafter, requisite information was obtained from SHO PS-17, Chandigarh who reported that complaint bearing No. ICMS/2024/020348 is under enquiry and the same was denied to the appellant as per the provisions of section 8 (1) (h) of RTI Act. The appellant was informed accordingly vide letter No. 307/RTI-24/CPIO-Central dated 01.11.2024.

### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought information on 02 points regarding complaint no. ICMS/2024/020348 i.e. copy of all documents & statements related to case and copy of all statements given and any other certified record pertaining to this case.

In reply, CPIO/Central had denied the sought information as per the provisions of section 8(1)(h) of RTI Act.

Now as far as the appeal is concerned, CPIO/Central has appropriately disposed of the RTI application as compliant no. ICMS/2024/020348 is still under enquiry and the requisite information cannot be supplied at this stage also. Hence, no more action is required.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
