**ORDER**

The appellant has preferred 1<sup>st</sup> appeal dated 28.10.2024 against the disposal of his RTI application dated 22.09.2024 by CPIO/South-West & CPIO/Admn with the contentions that requisite information was not provided to him.

**Information sought vide RTI application :-**

The appellant vide his RTI application has sought information on 02 points i.e. who is the enquiry officer who conducted the investigation and copy of investigation report in reference no. C-6913227302 of PSHRC.

**COMMENTS OF CPIO/Admn :-**

CPIO/Admn vide his comments submitted that RTI application was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from I/C HAC and the same was supplied to the applicant in the shape of 41 pages vide letter No. 215, 216, 232 & 292/RTI/DSP/Admn Dated 04.11.2024.

**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought information on 02 points i.e. who is the enquiry officer who conducted the investigation and copy of investigation report in reference no. C-6913227302 of PSHRC.

In reply, CPIO/Admn has already supplied the available information to the appellant.

Now as far as the appeal is concerned, information pertaining to point no. 01 (who is the enquiry officer who conducted the investigation), CPIO/Admn has inappropriately denied the sought information to the appellant without going through the contents of the RTI application. Hence, CPIO/Admn is hereby directed to provide the requisite information to the appellant as per the provisions of RTI Act.




Further, information pertaining to point no. 02 (copy of investigation report in reference C-6913227302 of PSHRC), CPIO/Admn has already provided the sought information to the appellant. Hence, no more action is required to be taken on this instant 1<sup>st</sup> appeal.

However, CPIO/Admn is hereby advised to dispose of the RTI application within the stipulated time period.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
