ORDER

The appellant has preferred 1st appeal against the reply of CPIO/Hqrs, South, Central & W&CSU in connection with RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 124/UT/RTI/FAA/SSP dated 10.11.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information i.e. certified copies of complaints, action taken report of five complaints bearing no. PW 201913910, 2020-13966/24669 and 2021-104570/08707.

COMMENTS OF CPIO/PHQ :-

CPIO/PHQ submitted that appellant has sought information RTI application. From perusal of RTI application, it found that point No. 01 i.e. complaint No. 20191391 pertains to us and as per record; the same is consigned with HAC Branch. Accordingly, after obtaining the information from HAC Branch, appellant was informed to collect the same from the office of undersigned and the same had been collected by the appellant.

COMMENTS OF CPIO/South: -

CPIO/South submitted that appellant has sought information RTI application. Thereafter, the requisite information was obtained from

all SHOs under the jurisdiction of CPIO, and prepared point wise reply which was supplied to applicant vide No. 502/CPIO/South dated 30.09.2021.

COMMENTS OF CPIO/Central : -

CPIO/Central submitted that appellant has sought information RTI application. Thereafter, the requisite information i.e. complaint no. 202108707 was inquired in PS-11 and the same has been sent senior officers. As per record of Public Window System, the same has been found with ASP/South office. The same has been transferred to CPIO/South and appellant has also been apprised about the same.

COMMENTS OF CPIO/W&CSU: -

CPIO/W&CSU submitted that appellant has sought information RTI application. Thereafter, the requisite information was obtained from SHO-WPS and point wise reply was supplied to applicant vide memo no. RTI-268/UT/DSP/W&CSU dated 30.09.2021

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/PHQ, South, Central & W&CSU vis-à-vis material available on record which revealed that appellant had sought information i.e. certified copies of complaints, action taken report of five complaints bearing no. PW 201913910, 2020-13966/24669 and 2021-104570/08707.


Insofar appeal is concerned, information related to point no. 01 i.e. copy of complaint no. PW201913910 has already been collected by appellant by hand, therefore, no more action is required in regard on this point.

With regards to Point No. 2, 3 and 5, complaints in questions are still under investigation, therefore requisite information cannot be supplied at this stage. Hence, CPIO/South has appropriately denied the information under section 8 (1) (h) of RTI Act. However, keeping in view of the objectives of RTI Act, CPIO/South is hereby directed to supply the certified copy of the complaint to the applicant.

Whereas point no. 04 is concerned, it relates with office of CPIO/W&CSU and the complaint in question is still under enquiry,

therefore; CPIO/W&CSU is hereby directed to provide copy of the complaint to the appellant. With these directions, appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
