ORDER

The appellant has preferred 1st appeal against the reply of CPIO/South in connection with RTI application with the contentions that requisite information was not supplied to her. The instant appeal was diarized vide No. 128/UT/RTI/FAA/SSP dated 17.11.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information regarding Complaint No. PW 202116987 dated 16/07/2021 i.e. copies/transcripts of records available.

COMMENTS OF CPIO/SOUTH: -

CPIO/South submitted that appellant has sought information vide his online RTI application. The sought information is pending under enquiry. Hence, denied under 8 (1) (h) of RTI Act. The appellant has been appraised through mail vide no. 581/CPIO/South, dated 05.11.2021.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought information regarding Complaint No. PW 202116987 dated 16/07/2021 i.e. copies/transcripts of records available.

Insofar as appeal is concerned, it is clear from the record of Public Window that complaint in question i.e. PW No. PW 202116987 is

still under enquiry; therefore, requisite information cannot be supplied at this stage. Hence, CPIO/South had appropriately denied the requisite information u/s 8(1) (h) of RTI Act. However, for achieving the objectives of RTI Act, CPIO/South is hereby directed to provide the copy of complaint to the appellant. Accordingly, appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
