ORDER

The appellant has preferred 1st appeal dated 28.10.2024 against the disposal of his RTI application dated 21.09.2024 by CPIO/Central & CPIO/Admn with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application has sought information on 05 points i.e. copy of complete investigation report alongwith statements of complaint no. ICMS/2024/006994, copy of complete investigation report alongwith statements of complaint no. ICMS/2024/011349, Copy of request submitted by Mrs Kulbir Kaur and Mrs Jasmine Kaur for police verification of earlier and present occupants alongwith police verification reports, proof of residing submitted by Mrs Kulbir Kaur and Mrs Jasmine Kaur, copy of rules which permit the resident to reside in Chandigarh without police verification.

COMMENTS OF CPIO/Admn :-

CPIO/Admn vide his comments submitted that RTI application was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from I/C HAC and the same was supplied to the applicant in the shape of 30 pages vide letter No. 327/RTI-24/DSP/Admn dated 22.11.2024.

COMMENTS OF CPIO/Central:-

CPIO/Central vide his comments submitted that RTI application was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from SHO PS-11 who reported that sought information is personal in nature and relates to third party. Hence, the same was denied to the appellant as per the provisions of section 8 (1) (j) of RTI Act, vide no. 268/RTI-24/CPIO-Central dated 11.10.2024.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO's vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought information on 05 points i.e. copy of complete investigation report alongwith statements of complaint no. ICMS/2024/006994, copy of complete investigation report alongwith statements of complaint no. ICMS/2024/011349, Copy of request submitted by Mrs Kulbir Kaur and Mrs Jasmine Kaur for police verification of earlier and present occupants alongwith police verification reports, proof of residing submitted by Mrs Kulbir Kaur and Mrs Jasmine Kaur, copy of rules which permit the resident to reside in Chandigarh without police verification.

Now as far as appeal is concerned, information pertaining to point no. 1 & 2, CPIO/Admn has already supplied the available information to the appellant.

Information pertaining to point no. 03 & 04, appellant has sought the police verification report as well as resident proof submitted by Mrs Kulbir Kaur and Mrs Jasmine Kaur, in which CPIO/Central has appropriately denied the sought information to the appellant as per the provisions of section 8 (1) (j) of RTI Act, as sought information is personal in nature and no larger public interest would be served by disclosing such information to the appellant.

As far as point no. 05 is concerned, the appellant has raised the queries by seeking rules/ instructions for permitting the resident to reside in Chandigarh without police verification, and the requisite information is in question form and falls outside the purview of section 2(f) of RTI Act.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
