**ORDER**

The appellant has preferred 1<sup>st</sup> appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 133/UT/RTI/FAA/SSP dated 24.11.2021 for further proceeding under RTI Act.

**INFORMATION SOUGHT IN RTI APPLICATION:-**

Appellant had sought complete record of complaint No PW-202108375 along with action taken report, copy of notings and status report.

**COMMENTS OF CPIO/South: -**

CPIO/South submitted that application of the appellant was received online for supplying requisite information. After obtaining the requisite information from SHO-36, requisite information was denied u/s 8(1)(h) of RTI Act as complaints in question are still under enquiry with ASI Balkasr Singh. Appellant has been apprised vide memo no. 539/CPIO/South dated 21.10.2021.

**DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought complete record of complaint No PW-202108375 along with action taken report, copy of notings and status report.

Insofar as appeal is concerned, it is clear that complaint in question are still under enquiry, therefore, requisite information cannot be supplied at this stage. However, CPIO/South is hereby directed to apprise about the status of complaints to the appellant. Accordingly, appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
